### MINUTES OF THE MEETING HELD ON 07.06.2016 AT 11 AM

#### IN THE CHAMBER OF CONTROLLER (LM)

During the meeting both ACLMs Shri Pravir Jain and Shri Shalesh Kumar were present.

The following issues were discussed :

- ACLMs inaction to visit the zones and take remedial action in their respective zones despite constant complaints from the public, other quarters as is evident from the PGMS portal and vigilance complaints. Till date Shri Shales Kumar has done only 1 inspection in North Zone and Shri Pravir Jain has done only 3 Inspections at New Delhi, Central and East Zones only, despite clear orders in this regard issued on 31.05.2016 to the ACs to conduct regular inspections in view of Hon'ble Minister's visit and his note dated 26.05.2016.

Action : Both ACLMs

- ACLMs and ZOs have not been monitoring the reasons for shortfall in revenue vis a vis the target fixed. In the month of May, 2016 against Rs.81.40 lakhs only Rs.62.60 lakhs were collected and till date there is a revenue short fall of 23.54% from the target fixed. The major defaulters in this regard are North West, North East and New Delhi Zones. The Department is presently short by Rs.35 lakhs from the target fixed for the first two months.

Action : Both ACLMs and all ZOs

- In view of Hon'ble Minister's visit on 26.05.2016 corrective steps taken in this regard have not been put up by the concerned ACLMs depicting the improvements made in their respective zones. In view of the position and status which has been uploaded on Facebook of each office of the Department as on 02.06.2016. ATR in this regard would be submitted in the inspection report of the respective ACLMs.

Action : Both ACLMs

- The output report for the month of April and May, 2016 clearly shows that there is severe fall in enforcement activities vis a vis that of 2014-15 wherein 8956 inspections were done in the whole year whereas in the year 2016-17 only a limited number of inspections were done in the month of April and May, 2016. Hence the need for sending teams regular inspections is required.

- Action : Sh. Shalesh, ACLM

- As intimated earlier on many files the issue of shortage of staff would be taken up by both the ACLMs on weekly basis with the Services Department as the Department is short by 50% of the sanctioned staff.

- Action : Both ACLMs



- Some of the important pending issues were sent to both the ACLMs by email on which compliance has still not been put up by the concerned ACLMs which are as follows.

- i. Compliance of DEOs bio-metric attendance has still not been received from both the ACLMs.
- ii. Reasons for shortfall in collection in the months of April and May, 2016.
- iii. Steps taken in pursuance of Hon'ble Minister's visit vide his note dated 26.5.2016.
- iv. Checking of reports of Registers / LD 4 and LR 4 to be maintained by Dealer / Manufacturer / Repairer. No report in this regard has been received till date. As there is no compliance from the concerned ZOs as stated by the ACLMs, on this issues Memos will be issued by the concerned ACLMs.

Action : Both ACLMs

- The issue of JMAs would also be put for the Secretary's perusal in view of complaint received in this regard which was discussed with both the ACLMs.

Action : Both ACLMs

- The output reports about pendency of important papers be monitored regularly as presently many important replies to the Special Vigilance Commissioner, Govt of India, Ministry of Consumer Affairs and Audit Team has already got delayed.
