Minutes of Meeting

Hon'ble Minister, Food & Civil Supplies and Consumer Affairs took a review meeting on 29.09.2016 in his Conference Room with the Secretary, Legal Metrology and Controller, Asst. Controllers Weights & Measures Department along with other officers to review the functioning of the Department.

During the meeting, Hon'ble Minister asked the officers about the plan to ensure that accurate net quantities of various commodities are made available to the consumers especially during the festive season of Dussehra and Diwali.

Hon'ble Minister directed the Department that all the Zonal Officers and Inspectors Legal Metrological Officials working in Weights and Measure Department will visit the markets/establishments independently regularly in their respective areas and submit inspection report on weekly basis, to their respective Controlling Officers. It was also directed that the field staff will ensure that the norms of Packaged Commodity Rules are strictly being followed by the shop-keepers/manufacturers/dealers. They will also ensure that only stamped electronic/manual/weighing instruments are being used by them.

Hon'ble Minister also emphasized about the accurate stamping of Auto Taxi Metres, stamping of nozzles at Petrol Pumps, Electronic Weighing Machines and manual weighing instruments because, if the erring instruments are being used by the shopkeepers and other agencies, it will deeply affect upon the consumers' rights. Hon'ble Minister directed that no laxity on this account will be tolerated.

Hon'ble Minister asked the department to give publicity to the do's and don't's for the manufacturers, repairers, shop-keepers, establishments as well as general public regarding weights and measures and also Packaged Commodity Rules.
